## **Price giving**

Saturday – Sum of A1, A2, A3 trials in categories Small, Medium, Intermediate, Large.

Relay – first three places in each height category (Small, Medium, Intermediate, Large).

Sunday – Open Jumping: the fastest clean run in each height category is evaluated.

Open Agility 1: every clean run is evaluated.

Open Agility Final – Variant 1: The winner is determined by the sum of Open Agility 1 and the final run.

At presentation it is necessary to submit a vaccination certificate with valid vaccination or PET PASSPORT.

Foreign participants must have PET PASSPORT.

## **General Provisions**

Free running of dogs near the course is not allowed.

Walking dogs is outside the venue.

The handler is responsible for damage caused by the dog.

In case of cancellation of the competition due to force majeure, the entry fee forfeits in favor of the organizer, unless the organizer decides otherwise.

A protest can be submitted in writing after paying a deposit of 20 € until the official end of the competition.
